### TERMS AND CONDITIONS:

#### 1. Firm Location & Registration:

- The head office of the firm must be located in Uttarakhand.
- The firm must be a registered Chartered Accountant (CA) firm with a valid ICAI registration.

#### 2. Experience & Compliance:

- The firm should have a minimum of 10 years of experience in handling accounting and financial statement preparation for government institutions or universities.
- Preference will be given to firms having experience with state-funded educational institutions.

- c. The firm should not have been blacklisted by any government or semi-government organization.

**3. Scope of Work:**

- a. The firm shall be responsible for doing the accounting and preparation of financial statements for the years as mentioned above.
- b. The firm shall be responsible for assisting the existing CA of the university in the merger of the Rishikesh Campus accounts with the University's accounts.
- c. The firm will also be responsible for highlighting and assisting in compliance with government rules and regulations.

**4. Quotation Submission:**

- a. Quotations should be submitted in a sealed envelope or via email to the designated university office.
- b. The last date for submission is 8th April 2025.
- c. Late submissions will not be entertained.
- d. The quotation must be in the prescribed format, clearly mentioning the quoted amount for each financial year and the total amount (inclusive of taxes).

**5. Payment Terms:**

- a. Payment will be made within 30 days after the financial statements are successfully submitted to the University.
- b. Any statutory deductions (such as **TDS, GST, etc.**) will be applicable as per government norms.
